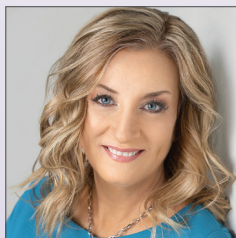

Our Cottage Meetings are growing like CRAZY! We continue to hold them online via zoom with an average of 250 moms participating. We are also rapidly growing our in-home Cottage Meetings. Last week, I spoke at an event with about 15 moms in a private home in Tyler Texas. The next day, we had 5 Cottage Meetings started with over 150 moms signed up—in one town!



We have officially launched Cottage Meetings for Kids and are half-way through our online series geared directly toward children. 148 families signed up, and it's been going great! We also launched our Liberty Kids Club, and we are in the process of developing a summer camp program—kind of like vacation Bible school but for liberty.

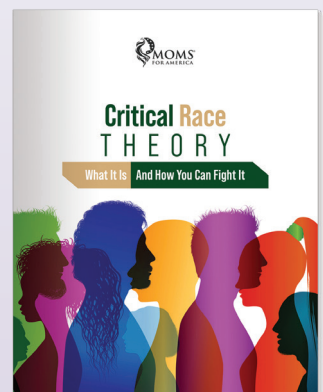
Empower Moms Booklets

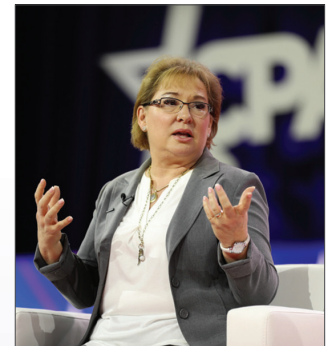
Events

Legislation

Our moms, through *Moms for America Action* (our 501c4) have been very active this legislative session on both the state and national levels. We have publicly endorsed and supported several bills in Congress, including **Marsha Blackburn’s bipartisan bill** protecting children online, **Marjorie Taylor Green’s bill** protecting children from gender mutilation, and **Burgess Owens’ Parental Rights Bill**. We have developed great relationships with many conservative members of Congress—many of whom we endorsed and helped get elected through our **MomVote** resources and voter guides. I frequently receive texts and emails directly from these members asking my opinion on legislation they are considering proposing or requesting our support on legislation they have introduced. Moms finally have a seat at the table and it is so refreshing to have this kind of support in Congress.

On the state level, we are actively promoting our FCC Standard Bill in Texas with great success, and 7 other states are picking it up. The bill has a simple concept: if you can’t show it on TV and can’t air it on radio, you can’t have it in the classroom. I have personally shared the concept of the bill with several members of Congress, and there will soon be a bill introduced in the house focusing on the FCC standard. In Texas, Representative Patterson has taken up our FCC Standard, rolling it into his bill, and he has been actively promoting the simple concept in committee, publicly in the media, and on social media platforms.



Litigation

We have been very blessed to receive support from several nonprofit legal centers, such as Alliance Defending Freedom, First Liberty, and Goldwater Institute. We also have started a legal fund to help moms facing legal issues in their schools and guide them through the process of filing public records requests. Because of this, we have been able to help moms successfully file cases and have won several with a simple letter from a law firm.



CDC Lawsuit — We are actively engaged in this very important project that will expose the CDC’s deception, empower moms to protect their children against these draconian mandates, and lay the responsibility for these tyrannical decisions where they belong—with the elected representatives, schools, and hospitals that mandate and enforce them. We have a fantastic attorney taking the lead. He is working with Simone Gold and her team at America’s Frontline Doctors as well as several other experts, professionals, and law firms—including the Goldwater Institute. We are carefully constructing our case alongside a public policy and media relations campaign that will inform the public, expose the deception, and open the door to additional lawsuits targeting school districts, hospitals, and local jurisdictions. We can’t wait to share our findings and developments in this legal case as moms file legal suit against the CDC.



15 State Plan

In preparation for the state and local elections this year, as well as the 2024 elections, we have developed a 15 State Plan to engage and mobilize moms to get out the mom vote and empower them to vote their values with confidence. This very strategic, comprehensive, grassroots plan has a proven record of success. We know how the left wins because we found their entire playbook on the Harris County Texas Democratic Party website in 2009. We use their own playbook against them and have been successfully doing so since 2010. The only thing that has ever slowed us down or held us back is funding. Wherever we have the funds to launch the plan, we have wins.
