

#### **Membership & Education**

In 2023, the Membership and Education Department grew its influence dramatically among women in the United States. Nationwide, **membership inquiries are up 94%**, State Liaisons have increased from 13 to 20 and onboarding of Moms for America Group Leaders has increased by 85% with 91 very active *Moms for America* groups and over 200 affiliate groups. Monthly leadership training sessions continue to develop our volunteer leaders to grow groups in their state and interact with both elected and appointed representatives in their local and state governments.

Our Membership and Education team continue to expand our outreach and offerings.

 Our Grammy Grizzlies group has had consistent growth and now boasts 282 Facebook group members from 32 states. These are the mamas leading the charge in their communities. They have provided hundreds of volunteer hours mentoring young moms, recruiting new members, drafting the Grammy Guide, and providing content for the Grammy Grizzly website which is now under development.  In August, we moved our Homeschool Moms2Moms webinar under Membership & Education. It has since seen an 11.8% increase in registrations with hundreds of moms tuning in live or via download.

Our online and in-home Cottage Meetings have grown exponentially. Moms across the country are catching the fire of freedom through these small group meetings as they invite friends and neighbors to gather in their homes or join us live online for any one of our virtual series. Classes can also be downloaded to listen or view at no charge.

Our live online series (using zoom) have seen tremendous growth. These include the original 12 Cottage Meetings, Healing of America 16-part series and the 5,000 Year Leap. Registrations for these online classes increased a whopping 423% in 2023! Our Fall Cottage Meeting series was led by our very own Founder and President, Kimberly Fletcher. #### Moms for America Resources

Our resources continue to grow with booklets that are free to download. Current booklets include topics such as Gender Confusion, Social Emotional Learning (SEL), and our Grammy Grizzlies Guide. They are now all available in Spanish as well. You can read and download any of our booklets here.

#### Moms for America Español

We are so excited with our new expanding Hispanic Outreach! We now have a whole starter kit for Spanish-speaking moms. We completed the

Spanish translations for our CRT Guide, Parental Rights Guide, our book "Raising A New Generation of Patriots" and just completed the Cottage Meetings in Spanish. We have also produced several videos featuring our Latina moms doing promo pieces for Moms for America resources and Mom Vote. The "En Español" section of our website will launch in the next month with all the valuable resources these moms have been requesting.

#### **CDC Lawsuit**

When we first presented our idea of suing the CDC to top attorneys they told us everyone was looking for the smoking

gun to sue them but they were too protected. But our Founder and President, Kimberly Fletcher, was convinced there was a way so we hired an attorney to do the research. After eight long months of searching every angle and even slightly related case, the verdict was in—we had a case.

We sent our findings to those same top attorneys, and they were floored with what we discovered. We are going after the PREP Act itself on two constitutional points. These top constitutional lawyers said this case could go all the way to the Supreme Court. One of the attorneys commented, "I can't believe it was moms that found the smoking gun."

We have compiled a top team of attorneys led by lead attorney, Erik Luckau and retained the law firm of Jeff Childress who is now the lead litigator in our case. Our team of legal and medical consultants include Michael Farris of Alliance Defending Freedom, Tom Fitton of Judicial Watch, the Goldwater Institute and several top medical professionals such as Dr. Robert Malone and Dr. Peter McCullough. We are now moving into the litigation phase of the case. We have twelve very good plaintiffs and expect to have the case in District Court by Spring.

We have reached over 125 thousand people across the country with school board training, candidate trainings, educational webinars, meetings and contact inquiries for school board issues.

#### Dr. Kelly Kohl's testimony before Ohio House Committee

Dr. Kelly Kohls, Senior Director Schoolboard Leadership Project for *Moms for America* and Director of the National School Board Leadership Council spoke at the Ohio House Higher Education Committee in October on the H.B. No. 183 Bill regarding single-sex bathroom access in schools and universities. Kelly spoke about the harm that allowing transgender individuals into women's sports and into the safe spaces for teens and women in both schools and sports. Watch her testimony **here**.

#### **School Board Leadership Project**

This year Kelly has trained 75 school board members, hosted or participated in 35 training webinars, and provided 500 private consultations and legal referrals. We have also filed and won 10 court cases and reversed over two dozen school district policies at the state and local levels. In addition, our work has led to resignations of school board members and superintendents in 7 school districts. Watch a video testimony **here** from Ivy, a school board member in Colorado.

#### Aly Legge, Director of Civic Engagement, released our School Board Ambassador training series.

Our ambassadors are trained on the proper roles of government pertaining to the school district. Training also includes how to build valuable relationships with those hired and elected in the school district to be the catalyst of change in their local schools. We have had 4 training sessions with 80 registrants joining this initiative, eager to learn more about becoming School District Ambassadors. These Ambassadors create a relational network with parents, teachers, and school board members in their school district and provide a powerful counter voice to the radical union agenda.

Our goal is to have a fully trained School District Ambassador in every one of the 13,452 school districts in the country.

#### Website Redesign

The importance of online accessibility and connectivity cannot be overstated. Our team has been hard at work on our fully updated and redesigned website. With greater visual appeal, ease of navigation, and more resources than ever, our new website will offer moms a lot.

Our tech team has had to meet the challenges of being deplatformed and censored for our content speaking the



truth about transgender ideology and medical freedom. Tech giants can, without warning, disable our accounts, remove content, and prevent people from seeing our posts if they disagree with what we or our guests are saying. We are storing all of our content securely on our own servers to prevent the loss of any material going forward. Additionally, we are working to find vendors who support free speech and will offer unbiased and uninterrupted service. Our website averages 3 million page views annually. With our new, more user-friendly website we plan to double those numbers in 2024.

#### **Podcast Update**

The Moms for America Podcast continues to grow reaching record numbers 2023. We've had over 400,000 downloads and views across all platforms this year. Some of our most popular episodes include President Donald Trump, Nikki Haley, Vivek Ramaswamy, Kirk Cameron, Dr. Miriam Grossman, Riley Gaines and many moms with courageous stories.






# **A Few Special Highlights**

#### FCC Bill - Moms for America with John Rich

*Moms for America* spearheaded ground-breaking legislation in Texas championing the FCC Standards Bill, also known as the READER Act. This simple legislation protects children from inappropriate material in the public school. The bill began with the simple idea: "If you can't show it on TV, and you can't air it on the radio, you can't have it in the classroom."

Here's an **interview** with John Rich and Moms for America President and CEO Kimberly Fletcher after the bill was signed into Texas Law on June 12. A similar bill was also passed in Louisiana in August. *Moms for America Action* works with state legislators to identify or draft bills that reflect the FCC Standard, protecting children from obscene, inappropriate content targeting 5 areas: classroom books, school library books, online curriculum, curriculum developers and adult instruction. An FCC Standard Bill is being introduced in 12 states in the 2024 Legislative session.

#### **10 State Plan**

In preparation for the state and local elections this year, as well as the 2024 elections, we have developed a 10 State Plan to engage and mobilize moms to get out the mom vote and empower them to vote their values with confidence. This very strategic, comprehensive, grassroots plan has a proven record of success. We know how the left wins because we found their entire playbook on the Harris County Texas Democratic Party website in 2009. We use their own playbook against them and have been successfully doing so since 2010. The only thing that has ever slowed us down or held us back is funding. Wherever we have the funds to launch the plan, we have wins.



# **Media & Marketing**

#### Social Media Growth in 2023!

Despite being constantly blocked, shadow-banned and deplatformed from social media outlets from Vimeo to Facebook, **Moms for America's** social media has grown in 2023—thanks largely to Elon Musk taking over Twitter (now X).

After launching on Truth Social later this year, we went from 0 to 1,830 users. Facebook grew from 39,137 to 41,565 with our biggest spike on Instagram which grew from 8,188 followers to

22,379. After having out account permanently suspended and losing all our data, we are not back online (thanks to Elon Musk) and growing back our presence. This year we successfully went from 1,777 followers to 4,315.

#### **Media Appearances**

*Moms for America* continues to be requested by media on a variety of topics.

In 2023 our team members both were interviewed and highlighted in local and national media more than 100 times. We have been called on to comment on topics such as child trafficking, gender confusion, and parental rights. Appearances include on Fox News, OANN, Newsmax, C-SPAN, News Nation, Sirius XM, and The Blaze.


#### **Earned and Print Media**

In an effort to expand our brand and reach more moms, we launched a series of 10 ad campaigns across Meta platforms in November. The campaign aimed to resonate with mothers and like-minded individuals, fostering

Collectively, they reached an impressive milestone, engaging with 579,986 individuals. The ads themselves garnered a total of 621,523 views, significantly bolstering *Moms for America's* visibility with moms.

#### What Makes Moms for America Unique?

*Moms for America* is a national organization that focuses on supporting moms locally. While we do have a strong national presence in media, politics, and policy, it is our grassroots network that sets us apart. We have over 100 Moms for

America groups, but we also have hundreds of affiliate groups we work with—moms that gathered after 2020 to protect their children from government overreach. They range from a small group of moms meeting together to thousands on a Facebook group. They may not adopt the specific Moms for America brand, but they are part of our network of moms' groups.

We are able to provide support, training, and resources to these groups they would not otherwise have access to. We can get local stories on national news, help videos go viral, provide press releases, graphics, marketing support, educational programs, and top-notch grassroots training to our local groups and affiliates allowing them to be more effective in guiding policy and participating in elections. It is local action creating national impact.

In addition, our Moms for America groups are locally branded. If moms just show up to school board meetings with Moms for America shirts, school board members look at them like a national organization butting their nose into their business. But if they show up with their California Moms

for America or Dallas County Moms for America shirts, those elected representatives know they live there, work there, shop there, and vote there. That is a game-changer!

Moms who go through our training learn the power of building relationships and focusing on principle to effect policy. They don't just show up angry, they show up empowered and that leads to wins in promoting principles of liberty in the home, in their communities, and through their vote.
